The subject of this procedure is the procurement of the reconstruction of TS 110/x kV Zenica 3 in the scope of: preparation and completion of project documentation and obtaining of necessary permits for construction and use of the facility, procurement and installation of two new power transformers T1 and T2 110/21(10,5)/10, 5 kV – 40 MVA, procurement and

installation of new HV equipment (in scope: two complete 110 kV transformer bays in hybrid GIS design, two complete 110 kV transmission line bays in hybrid GIS design, two 110 kV measuring bays in standard design, and a bay for sectioning of 110 kV busbars), procurement and installation of a new 20 kV and 10 kV medium voltage switchgear, procurement and installation of protection and control cabinets (for two transformer bays and for two transmission line and measuring bays, three protection and control devices for the existing 35 kV switchgears), procurement and installation of SCADA system, procurement and installation of self-consumption equipment (auxiliary voltage distribution cabinet 3x230/400 V AC; auxiliary voltage distribution cabinet 220 V DC), procurement and installation of power and signal cables, displacement of existing power transformers T1 and T2 into the area of TS Zenica 3 after dismantling by the Contractor, dismantling of existing equipment in the 110 kV bays, dismantling of the existing medium voltage switchgear 35 kV, 20 kV and 10 kV, construction and electrical installation works, functional tests, commissioning of the facility, all in accordance with the project assignment, technical specifications and requirements for equipment, service and works and other requested requirements specified in this tender documentation, based on the needs of the Contracting authority.
